


COUNCIL MEMBER – PLACE ONE

COUNCIL MEMBER – PLACE THREE




COUNCIL MEMBER – PLACE FOUR

**MINUTES FROM A REGULAR MEETING
OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD
January 2, 2024**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 5:30 p.m. on the 2nd day of January 2024 being the scheduled place for said meeting once the previously held work session ended. The meeting was called to order by Ken Sockwell, Council President. On roll call the following members were found to be present or absent, as indicated:

Ken Sockwell, Council President, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor Mike Lockhart was also present. Brittney Walker, City Clerk/Treasurer, was present and kept the minutes of the meeting.

The invocation was given by Chief Reck. President Ken Sockwell led in the pledge of allegiance.

Upon motion duly made by Council Member Moore and seconded by Council Member Clark and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of December 18th, 2023, and approved the minutes as written.

Mayor Lockhart thanked all of the city departments for their work throughout the holidays. He also shared that the new RaceTrac is open.

President Sockwell announced that the next item of business was to approve a resolution for the purchase of Rev 4 Firefighting Equipment and Rescue Tools. Council Member Clark made a motion to approve the resolution; Council Member Hall seconded that motion.

RESOLUTION NUMBER 3300-24

BE IT RESOLVED, that the City Council of the City of Muscle Shoals, Alabama approved the purchase of Rev 4 Firefighting Equipment and Rescue Tools to be utilized in the Fire Department; and

WHEREAS, that the Procurement Agent advised that the purchase must comply with the Alabama Competitive Bid Law requirements, and that a cooperative contract approved by the State of Alabama is valid for such purchase; and

WHEREAS, the Procurement Agent further advised that the total purchase price for Rev 4 Firefighting Equipment and Rescue Tools is \$49,065.00 to be purchased from Municipal Emergency Services and further Municipal Emergency Services is the awarded contractual vendor for said item with Sourcewell, a State of Alabama approved governmental purchasing cooperative; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Muscle Shoals that Municipal Emergency Services is awarded the purchase of the approved Rev 4 Firefighting Equipment and Rescue Tools for the total purchase price of \$49,065.00.

ADOPTED this 2nd day of January, 2024.

President Sockwell stated that approval of the motion and second was before the Council. Those in favor of the application would indicate so by voting aye and those opposed would indicate by voting nay. Upon said question being put to a vote, a roll call was had, and the vote recorded as follows:



There being no further business to come before the meeting, upon the motion duly made and seconded the meeting was adjourned.



COUNCIL MEMBER – PLACE THREE




COUNCIL MEMBER – PLACE FOUR
