MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD June 20, 2022

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:00 p.m. on the 20th day of June, 2022 being the scheduled time and place for said meeting. The meeting was called to order by Ken Sockwell, Council President. On roll call the following members were found to be present or absent, as indicated:

Ken Sockwell, Council President, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor Mike Lockhart was also present. Elaine Coan, City Clerk, was present and kept the minutes of the meeting.

The invocation was given by Chief Clint Reck. Council President Ken Sockwell led in the pledge of allegiance.

Upon motion duly made by Council Member Thompson and seconded by Council Member Hall and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of June 7, 2022, and approved the minutes as written.

President Sockwell announced that the next item of business was a public hearing to consider the adoption of an ordinance to amend the Zoning Ordinance and Zoning Map of the City of Muscle Shoals, Alabama as follows:

ORDINANCE NO. 1546-22 AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND ZONING MAP OF THE CITY OF MUSCLE SHOALS, ALABAMA

Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows: That the following described area which is currently zoned M-1 and R-2 and is hereby incorporated in and made a part of the B-2 District, to wit:

Amending the ordinance to rezone property located at the corner of Second Street and Union Avenue from M-1 and R-2 to B-2. The property is located south of Second Street at the intersection with Union Avenue. The request includes two parcels, 07-08-34-1-007-014.000 and 07-08-34-1-007-013.000, and there are not structures on the lots.

The Council finds that legal notice of the proposed amendment to the Zoning Ordinance of the City of Muscle Shoals, Alabama, was published by posting the same in four (4) conspicuous places in the City of Muscle Shoals, Alabama, 15 days prior to the date hereof, there being no newspaper published in the City of Muscle Shoals, and said notice set for public hearing on the 20th day of June, 2022, at 6:00 p.m. in the Chambers of the Council of the City of Muscle Shoals located in the City Hall, Muscle Shoals, Alabama, for all persons to appear to be heard either for or against the adoption of said amendment; and

WHEREAS, said public hearing was held and President Sockwell announced that now was the proper time for persons in favor and those in opposition to the ordinance to be recognized.

There being no one wishing to speak, President Sockwell stated that approval of the ordinance was before the Council. All those in favor of the application would indicate so by voting aye and those opposed would indicate by voting nay. The Council finds that legal notice of the proposed amendment to the Zoning Ordinance of the City of Muscle Shoals, Alabama, was published by posting the same in four (4) conspicuous places in the City of Muscle Shoals, Alabama, 15 days prior to the date hereof, there being no newspaper published in the City of Muscle Shoals, and said notice set for public hearing on the 20th day of June, 2022, at 6:00 p.m. in the Chambers of the Council of the City of Muscle Shoals located in the City Hall, Muscle Shoals, Alabama, for all persons to appear to be heard either for or against the adoption of said amendment; and

ORDINANCE NO. 1547-22 AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND ZONING MAP OF THE CITY OF MUSCLE SHOALS, ALABAMA

Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows:

That the following described area which is currently zoned B-1 and is hereby incorporated in and made a part of the R-2 District, to wit:

Amending the ordinance to rezone property located at the corner of Broadway Street and Tennessee River Drive, 100 Broadway Street from B-1 to R-2. The property is located at the southeast corner of Broadway and Tennessee River Drive, north of River Road. The area includes two parcels, 08-04-19-1-003-045.000 and 08-04-19-1-003-044.000 in Colbert County Parcel Viewer, 0.45 and 0.37 acres respectively.

The Council finds that legal notice of the proposed amendment to the Zoning Ordinance of the City of Muscle Shoals, Alabama, was published by posting the same in four (4) conspicuous places in the City of Muscle Shoals, Alabama, 15 days prior to the date hereof, there being no newspaper published in the City of Muscle Shoals, and said notice set for public hearing on the 20th day of June, 2022, at 6:00 p.m. in the Chambers of the Council of the City of Muscle Shoals located in the City Hall, Muscle Shoals, Alabama, for all persons to appear to be heard either for or against the adoption of said amendment; and

WHEREAS, said public hearing was held and President Sockwell announced that now was the proper time for persons in favor and those in opposition to the ordinance to be recognized.

There being no one wishing to speak, President Sockwell stated that approval of the ordinance was before the Council. All those in favor of the application would indicate so by voting aye and those opposed would indicate by voting nay. Upon said question being put to a vote, a roll call was had and the vote was recorded as follows:

(Local Unit Retirees and Beneficiaries of Deceased Retirees)

BE IT RESOLVED that the City of Muscle Shoals, Alabama, through its City Council approves and elects to come under the provisions of Section 2 of Act 229 of the Regular Session of the 2022 Legislature.

BE IT FURTHER RESOLVED that the City of Muscle Shoals, Alabama agrees to provide all funds necessary to the Employees' Retirement System to cover the cost of the one-time lump sum payment as provided for by this Act for those eligible retirees and beneficiaries of deceased retirees of the City of Muscle Shoals, Alabama with the aforementioned lump sum payment being paid in October 2022.

Council Member Moore seconded the motion and upon motion being put to a vote, all voted "AYE" and "NAYS" were none.

President Sockwell announced that the resolution had been approved.

President Sockwell announced that the next item of business was consideration of a resolution to approve the submission of the 2023 Sidewalk & Pedestrian Improvement.

Council Member Hall introduced the following resolution and moved for its adoption:

STATE OF ALABAMA COLBERT COUNTY

RESOLUTION 3213-22

WHEREAS, the Alabama Department of Transportation is soliciting applications for Transportation Alternative Projects for FY 2023, and

WHEREAS, the City of Muscle Shoals desires to apply for and receive funding for the 2023 Sidewalk and Pedestrian Improvement Project to construct new sidewalks along Brown Street from Barrington Court to Sixth Street and on Webster Street from the current crosswalk to Avalon Avenue; and

WHEREAS, the estimated project construction cost including construction engineering and inspection (CE&I) totals \$542,069.00; and

WHEREAS, the City of Muscle Shoals agrees to provide \$56,563.58 of local funding; and

WHEREAS, the City of Muscle Shoals agrees to provide twenty percent (20%) and pay one hundred percent (100%) of any amount over the estimated project; and

NOW, THEREFORE BE IT RESOLVED, that the City of Muscle Shoals does hereby approve the submission of the 2023 Sidewalk and Pedestrian Improvement Project.

Council member Thompson seconded the motion and upon motion being put to a vote, all voted "AYE" and "NAYS" were none. President Sockwell announced that the resolution had been approved.

President Sockwell announced that the next meeting would be Tuesday, July 5, 2022 with the work session beginning at 5:00 p. m. for the purpose of the Civil Service Board and Utilities Board interviews.
