

**MINUTES FROM A REGULAR MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD  
October 6, 2014**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:15 p.m. on the 6<sup>th</sup> day of October, 2014 being the scheduled time and approved place for said meeting. The meeting was called to order by James Holland, President of the Council. The invocation was given by Ricky Williams. On roll call the following members were found to be present or absent, as indicated:

James Holland, President of the Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Ricky Williams, City Clerk, was present and kept the minutes of the meeting.

Upon motion duly made by Council Member Pampinto seconded by Council Member Willis and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of September 15, 2014 and approved the minutes as written.

President Holland announced that the next item of business was consideration of a resolution to award a bid for fencing at the Buena Vista pumping station.

**BE IT RESOLVED** by the Council of the City of Muscle Shoals, Alabama that;  
**WHEREAS**, the Procurement Agent did send out advertisements for bids for the installation of chain-link fencing surrounding the Buena Vista-Tyler retention pond, the bid opening being held September 25, 2014 at the City Hall of the City of Muscle Shoals, Alabama; and

**WHEREAS**, at the appointed time and place, as specified above, the following bids were opened and tabulated as follows; and

Athens Fence Company	\$58,300.00
Jones Fence Enterprises, Inc.	\$65,545.00

**WHEREAS**, the apparent lowest bidder, Athens Fence Company after evaluation of the submitted bids, has been determined as non-responsive due to the bidders failure to provide and include required documents with the bid submission and those documents being:

- 1) Completed compliance specification form
- 2) Addendum #1 form with signature

**WHEREAS**, that the apparent lowest, responsive and responsible bidder is Jones Fence Enterprises, Inc. with a bid price of \$65,545.00; and

**THEREFORE, BE IT RESOLVED** by the City Council of the City of Muscle Shoals that Jones Fence Enterprises, Inc. is now awarded the purchase and installation of chain-link fencing.

Council Member Lockhart seconded the motion and upon said motion being put to a vote all voted "AYE" and "NAYS" were none.

President Holland announced that the resolution had been approved.

At said time and place, all persons who desire to do so shall have the opportunity of being heard in opposition to or in favor of the approval of such license.
