#### MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD December 19, 2011

The Council of Muscle Shoals, Alabama met at the City Hall in said City at 6:05 p.m. on the 19<sup>th</sup> day of December, 2011 being the regularly scheduled time and approved place for said meeting. The meeting was called to order by David Bradford, Mayor of the City. The invocation was given by Paul McDougle. On roll call the following members were found to be present or absent, as indicated:

Upon motion duly made by Council Member Holland seconded by Council Member Pampinto and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of December 5, 2011 and approved the minutes as written.

Mayor Bradford announced that the next item of business was consideration of a resolution to award a bid for the reconstruction of the Muscle Shoals Living Center.

[1] That the City Architect did send out advertisements for bids for the renovations to the Muscle Shoals Senior Citizens Center the bid opening being set for the 8th day of December, 2011, at the City Hall of the City of Muscle Shoals, Alabama.

[3] The lowest, responsible, responsive bidder, after verifying the bid with the specifications, has been determined as Johnson Construction, Inc. with a total bid price of \$456,900.00 which includes Alternates #1(Aluminum Canopy) and Alternate #2 (Portable Stage Equipment).

[4] The bid submitted by Johnson Construction, Inc. was submitted with the omission of the time of completion that was required on the bid submission. It was determined that in the best interest of the city, the bidder had not received an unfair advantage and the omission was waived by the City as a minor informality and further, Johnson Construction, Inc. was allowed to cure the mistake by submitting a letter stating the time of completion on the same date of the bid opening;

**NOW, THEREFORE BE IT FURTHER RESOLVED**, that the apparent lowest, responsive and responsible bidder, Johnson Construction, Inc. is now awarded the bid based upon the base bid amount, with the addition of Alternates #1 and 2, for the total amount of \$456,900.00 for the renovations to the Muscle Shoals Senior Citizens Center.
