

**MINUTES FROM A REGULAR MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD**

April 2, 2012

The Council of Muscle Shoals, Alabama met at the City Hall in said City at 6:00 p.m. on the 2<sup>nd</sup> day of April, 2012 being the regularly scheduled time and approved place for said meeting. The meeting was called to order by David Bradford, Mayor of the City. The invocation was given by Bill Howard. On roll call the following members were found to be present or absent, as indicated:

David H. Bradford, Mayor of the City, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Richard Williams, City Clerk, was present and kept the minutes of the meeting.

At this time Mayor Bradford read aloud a proclamation declaring the week of April 22<sup>nd</sup> - 28<sup>th</sup> and April 25<sup>th</sup> as Parental Alienation Week and Day in the City.

Upon motion duly made by Council Member Holland seconded by Council Member Willis and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of March 19, 2012 and approved the minutes as written.

Mayor Bradford announced that the next item of business was the presentation of the City's financial audit for the year ended September 30, 2011 and the audit for the City's Post-employment Benefits Trust for the same period. Following their review, Mayor Bradford directed the City Clerk/Treasurer to spread the audits on the minutes of this meeting.

Mayor Bradford announced that the next item of business was consideration of a change in the next regular meeting set for Monday, April 16, 2012.

Council Member Willis moved that the April 16, 2012 regular meeting be changed to Monday, April 23, 2012 in the City Hall auditorium. The work session will begin at 4:30 pm and the regular meeting at 6:00 pm or upon the conclusion of the work session, whichever is later. Council Member Noles seconded the motion and upon said motion being put to a vote, all voted "AYE" and "NAYS" were none.

Mayor Bradford announced that the meeting date and time were approved.

There being no further business to come before the meeting, upon the motion duly made, seconded and unanimously carried, the meeting was adjourned.
