

**MINUTES FROM A REGULAR MEETING OF THE

April 5, 2010**

The Council of Muscle Shoals, Alabama met at the City Hall in said City at 6:05 p.m. on the 5th day of April, 2010 being the regularly scheduled time and approved place for said meeting.
