## MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD June 18, 2012

The Council of Muscle Shoals, Alabama met at the Muscle Shoals Living Center in said City at 6:00 p.m. on the 18<sup>th</sup> day of June, 2012 being the scheduled time and approved place for said meeting. The meeting was called to order by David Bradford, Mayor of the City. The invocation was given by Bill Howard. On roll call the following members were found to be present or absent, as indicated:

David H. Bradford, Mayor of the City, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Richard Williams, City Clerk, was present and kept the minutes of the meeting.

Upon motion duly made by Council Member Holland seconded by Council Member Noles and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of June 7, 2012 and approved the minutes as written.

Mayor Bradford announced that the next item of business was consideration of a resolution to establish a bank account for the Municipal Court Judicial Administration Fund.

Council Member Noles introduced the following resolution and moved for its immediate consideration:

## RESOLUTION NUMBER 2553 -12

**WHEREAS**, Act # 2012-535 of the Regular Session of the Alabama Legislature requires the establishment of a Municipal Court Judicial Administration Fund for municipal courts, and

**WHEREAS**, the Municipal Court Judicial Administration Fund is to be established to account for funds received from court costs collected pursuant to Act # 2012-535, and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Muscle Shoals, Alabama that there is hereby established the Municipal Court Judicial Administration Fund, a special revenue fund, to account for funds (exclusive of funds earmarked for the Corrections Fund, Municipal Court Fund and Cash Bond fund) received from court operations, and

**BE IT FURTHER RESOLVED** by the City Council that the City Clerk/Treasurer is authorized to establish with First Metro Bank a checking account for the maintenance of these funds, and

**BE IT FURTHER RESOLVED** by the City Council that the Municipal Judge and the Court Clerk or Court Magistrate be authorized to signs checks for this account.

Council Member Grissom seconded the motion and upon said motion being put to a vote, a roll call was had and the vote recorded as follows:

Mayor Bradford announced the vote and declared that the motion for unanimous consent for immediate consideration had been approved.
