

**MINUTES FROM A CONTINUED MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD  
September 4, 2012**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall Auditorium in said City at 12:00 o'clock noon on the 4<sup>th</sup> day of September, 2012 in a meeting continued from August 20, 2012. The meeting was called to order by James Holland, Mayor Pro-Tem of the City. On roll call the following members were found to be present or absent, as indicated:

James Holland, Mayor Pro-Tem of the City, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Richard Williams, City Clerk, was present and kept the minutes of the meeting.

Mayor Pro-Tem Holland noted that the only item of business was the canvass of the August 28, 2012 municipal election for place three on the City Council. City Clerk Richard Williams read aloud the results from the voting precincts.
