# MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD October 16, 2017

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:00 p.m. on the 16<sup>th</sup> day of October, 2017 being the scheduled time and approved place for said meeting. The meeting was called to order by Allen Noles, President of the Council. The invocation was given by Ricky Williams. On roll call the following members were found to be present or absent, as indicated:

Allen Noles, President of the Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor David Bradford was also present. Richard Williams, City Clerk, was present and kept the minutes of the meeting.

Upon motion duly made by Council Member Willis and seconded by Council Member Hall and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of October 2, 2017 and approved the minutes as written.

Mayor Bradford informed the Council that the design of the Industrial Access project to make road improvements at 6<sup>th</sup> Street and Wilson Dam was nearly complete. He also noted that Rual King and CityTrends had announced the opening of retail locations in the City. Shoetopia has recently opened. Mayor Bradford noted that the process to extend Boutique Air for an additional four years thru the Essential Air Service program at the Northwest Alabama Regional Airport is continuing.

#### AN ORDINANCE APPROVING THE EXPANSION OF A USE

WHEREAS, the City of Muscle Shoals, Alabama Zoning Ordinance as amended October 15,2001, Section 122-151(a)(4)(l)(l) allows mini-storage units only in an M-l zone, and

WHEREAS, YEAGER RENTAL PROPERTIES, LLC owns property located at 102 Broadway Ave, Muscle Shoals, Alabama, that is in a B-2 zone (legal description attached as Exhibit "A"), and

WHEREAS, the above stated property has been operating mini-storage units on the stated premises for more many years, well before the enactment of the current Zoning Ordinance which made said property a non-conforming use for the purpose of mini-storage units, and

WHEREAS, YEAGER RENTAL PROPERTIES, LLC desires to improve and expand the mini-storage units within the confines and fencing of the current property from 42 units, by adding an additional 75 modern mini-storage units, at great expense and property value enhancement (plans attached as Exhibit "B"), and

WHEREAS, the Planning Department of the City of Muscle Shoals does not have an appeal procedure in this particular instance for an exception to the improvement of this non-conforming use.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Muscle Shoals, Alabama, as follows:

- 1. The Council finds that in this singular instance, the expansion of the above stated non-conforming use is a proper improvement to the current property and can serve to benefit and enhance the value of the property to the City, and cause no harm to the surrounding properties, and to allow the expansion of the use is in the best interest of the City of Muscle Shoals and its citizens.
- 2. Furthermore, the Planning Department is directed to devise an appeal procedure to address future requests for appeals or variances from the current zoning ordinance in similar circumstances.

3. Furthermore, the Mayor, David Bradford, and the City Clerk, Ricky Williams, are authorized to execute and deliver any and all other documents necessary and required to enact this adopted ordinance.
