

**MINUTES FROM A REGULAR MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD  
November 16, 2020**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:20 p.m. on the 16<sup>th</sup> day of October, 2020 being the scheduled time and place for said meeting. The meeting was called to order by Ken Sockwell, Council President. The invocation was given by Sam . On roll call the following members were found to be present or absent, as indicated:

Allen Noles, Council President, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor David Bradford was also present. Elaine Coan, Assistant City Clerk, was present and kept the minutes of the meeting.

Upon motion duly made by Council Member Sockwell and seconded by Council Member Lockhart and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of September 21, 2020, the minutes of the October 6, 2020 regular meeting and work session and the minutes of the October 13, 2020 continued meeting and approved the minutes as written.

Council President Noles announced that the next item of business was consideration of a resolution to appoint a member to the Colbert County Tourism and Conventions Bureau Board.

Council Member Lockhart introduced the following resolution and moved for its adoption:

**WHEREAS**, the term of a member of the Colbert County Tourism and Conventions Bureau Board has expired and the City Council being desirous of making the necessary appointment to said board within the City;

**WHEREAS**, notice was given to the public of said pending vacancy and applications solicited for members to said board;

**WHEREAS**, the following individual made proper application and met the requirements for appointment, is eligible for appointment to fill the pending vacancy:

**WHEREAS**, Linda Whitaker Campbell was determined to be the sole applicant and otherwise qualified, and
