The Council of Muscle Shoals, Alabama met at the City Hall in said City at 6:00 p.m. on the 26th day of October 2006 being the time and place scheduled for a special meeting called for the purpose of awarding bids for infrastructure construction projects in the Shoals Research Airpark for the North American Lighting project. The apparent lowest, responsive and responsible bidder, APAC-Southeast, Inc., is now awarded the bid with deductive alternate for the construction of the roadway improvement project at the bid price of \$1,287,397.36.
