# MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD October 3, 2005

The Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall in said City at 6:30 p.m. on the 3<sup>rd</sup> day of October 2005 being the regularly scheduled time and approved place for said meeting. The meeting was called to order by David Bradford, Mayor of the City. The invocation was given by Robert Evans. On roll call the following members were found to be present or absent, as indicated:

PRESENT: JOE PAMPINTO, NEAL WILLIS, JERRY KNIGHT GRISSOM

JAMES HOLLAND, ALLEN NOLES, DAVID H. BRADFORD

ABSENT: NONE

Richard Williams, City Clerk of the City, was present and kept the minutes of the meeting.

David Bradford, Mayor of the City, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business.

Upon motion duly made by Council Member Holland, seconded by Council Member Pampinto unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting of September 19, 2005 and approved the minutes as written.

At this time Mayor Bradford presented a proclamation to the local chapter of the National Alliance for the Mentally III declaring October 2-8, 2005 as Mental Illness Awareness Week in Muscle Shoals.

At this time, Susann Hamlin, Director of the Colbert County Tourism Bureau presented a Certificate of Appreciation to the City for its support of the North Alabama Birding Trail.

Mayor Bradford announced that the next item of business was consideration of a resolution awarding the annual bid for concrete pipe.

Council Member Pampinto introduced the following resolution which was presented in the meeting and moved for its adoption:

BE IT RESOLVED by the City Council of the City of Muscle Shoals, Alabama, as follows:

- [1] That advertisements for bids for the purchase of concrete pipe for the fiscal year beginning October 1, 2005 were distributed, the bid opening set for the 28<sup>th</sup> day of September, 2005, at the City Hall of the City of Muscle Shoals, Alabama.
- [2] At the appointed time and place, as specified above, the following bids were opened and tabulated as follows with the basis of award being the percentage discount off the published price list submitted by the city to bidders:

BIDDER: Percent Discount off Published Price List: Set-A-Steps 0% Discount

[3] After verifying the bids with the specifications it has been determined that the lowest, responsive, responsible bidder submitting a bid for concrete pipe is Set-A-Steps. The bid is hereby awarded to Set-A-Steps for the price of the published price list.

Council Member Noles seconded the motion and upon said motion being put to a vote, all voted "AYE" and "NAYS" were none.

Mayor Bradford announced that the Resolution had been approved.

Mayor Bradford announced that the next item of business was the scheduling of a public hearing to consider the adoption of an Ordinance to amend the Zoning Ordinance and Zoning Map of the City of Muscle Shoals, Alabama. Mayor Bradford announced that at a meeting to be held at the City Hall in said City at 6:30 p.m. on the 7<sup>th</sup> day of November 2005, the Council will consider the adoption of an Ordinance to amend the Zoning Ordinance and Zoning Map of said City, the proposed Ordinance being as follows:

## ORDINANCE NO.\_\_\_\_\_AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND THE ZONING MAP OF THE CITY OF MUSCLE SHOALS, ALABAMA

Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows:

That the following described areas are hereby eliminated from the B-2 District in which it is now situated, and is hereby incorporated in and made a part of the M-1 District, to wit:

Begin at a point being the n.w. corner of the s.e. 1/4 of section 13, township 3s, range 10w, run s88^ 32' e for a distance of 712.27 feet, thence run s^28'w for a distance of 454.10 feet and being the point of beginning, thence run s88^32'e for a distance of 292.72 feet, thence run s!^ 28'w for a distance of 302.90 feet, thence run n88^32'w for a distance of 292.72 feet, thence run n1^ 28'e for a distance of 309.20 feet. Ten feet on either side of a line commencing at the midpoint between the Southwest corner of Lot 3306 of "Highland Park Subdivision Plat No. 9" in the City of Muscle Shoals, Colbert County, Alabama, according to the map and survey recorded in the Office of the Judge of Probate of Colbert County, Alabama, in Map Book 2, Page 70, and the Northwest corner of Lot 3411 in said subdivision; and running West a distance of 66 feet to the midpoint between the Southeast corner of Lot 3305 & the Northeast corner of Lot 3412 of said subdivision.


