

**MINUTES FROM A REGULAR MEETING OF THE
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD
November 18, 2019**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:00 p.m. on the 18th day of November, 2019 being the scheduled time and place for said meeting. The meeting was called to order by Allen Noles, President of the Council. The invocation was given by Ricky Williams. On roll call the following members were found to be present or absent, as indicated:

Allen Noles, President of the Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Upon motion duly made by Council Member Hall and seconded by Council Member Sockwell and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of November 4, 2019 and approved the minutes as written.

Mayor Bradford announced that the Alabama Department of Transportation had authorized the City to proceed with bidding the construction of sidewalks for the 2018 TAP program.

President Noles announced that the next item of business was consideration of the proposed 2019-2020 General Fund budget.

Council Member Sockwell introduced the proposed budget and moved for its immediate consideration:
