## MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD February 18, 2019

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:16 p.m. on the 18<sup>th</sup> day of February, 2019 being the scheduled time and place for said meeting. The meeting was called to order by Allen Noles, President of the Council. The invocation was given by Ricky Williams. On roll call the following members were found to be present or absent, as indicated:

Upon motion duly made by Council Member Hall and seconded by Council Member Sockwell and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of February 4, 2019 and approved the minutes as written.

President Noles announced that the next item of business was consideration of a resolution to declare certain property in the Public Works Department surplus and direct its disposal.

Council Member Sockwell introduced the following resolution and moved for its approval:

## **RESOLUTION NUMBER 2999 - 19**

**WHEREAS**, the City Council has been informed by the Public Works Director that certain equipment used in the performance of city operations are no longer required for use by the Public Works Department; and

**WHEREAS**, the City Council has determined that the said vehicles and equipment are surplus property and the City has no further use for said equipment due to their age and condition and it is not economical for the City to retool or refit the said vehicles and equipment in order that it be placed in service in the Public Works Department;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Muscle Shoals, Alabama that the equipment as noted in Exhibit "A" be declared surplus property and be disposed of by the Public Works Director by scrapping the items for salvage value; and

**BE IT FURTHER RESOLVED** that the Council does hereby authorize the Public Works Director to dispose of said items in such manner that no further expenditure by the City nor exposure of the City to any liability in the further use of said items; and

**BE IT FURTHER RESOLVED** that the Public Works Director is authorized to take the steps necessary to convey the above described equipment to the appropriate salvage company in a manner consistent with the terms and conditions and pursuant to this Resolution for and in consideration as previously stated.
