The Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall in said City at 6:00 p.m. on the 28th day of June 2004 being the time and place scheduled for a special meeting called for the purpose of awarding a bid for the construction of pressbox facilities at the Airport Sportsplex. - [1] That the City's Architect did send out advertisements for bids for the construction of pressbox facilities for the parks and recreation department, the bid opening being set for the 22nd day of June, 2004, at the City Hall of the City of Muscle Shoals, Alabama.
- [2] At the appointed time and place, as specified above, the following bids were opened and tabulated as follows:

Shoals General Contractors	\$267,000.00

[3] The lowest, responsible, responsive bidder, after verifying the bid with the specifications, has been determined as Butler Construction Company with a total bid price of \$260,000.00 for the construction of pressbox facilities.

The apparent low and best bidder, Butler Construction Company, is now awarded the bid for the construction of the pressbox facilities.

Council Member Noles seconded the motion and upon said motion being put to a vote, all voted "AYE". Voting "NAY" were none.

Mayor Bradford announced that the resolution had been approved.

There being no further business to come before the meeting, upon the motion duly made, seconded and unanimously carried, the meeting was adjourned.
