The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 7:05 p.m. on the 1st day of August, 2016 being the scheduled time and approved place for said meeting. The meeting was called to order by Allen Noles, President of the Council. The invocation was given by Police Captain Tommy Skipworth.
