

**MINUTES FROM A SPECIAL MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD  
August 11, 2016**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall conference room in said City at 6:05 p.m. on the 11<sup>th</sup> day of August, 2016 in a special called meeting for the purpose of selecting a Police Chief to replace retiring Police Chief Robert Evans. The meeting was called to order by Allen Noles, President of the Council. On roll call the following members were found to be present or absent, as indicated:

Allen Noles, President of the Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business.
