

**MINUTES FROM A CONTINUED MEETING OF THE
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD
August 30, 2016**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 12:00 noon on the 30th day of August, 2016 in a meeting continued from August 15, 2016. The meeting was called to order by Neal Willis, President Pro Tem of the Council. On roll call the following members were found to be present or absent, as indicated:

ABSENT: JOE PAMPINTO, ALLEN NOLES

Neal Willis, President Pro Tem of the Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor David Bradford was also present. Richard Williams, City Clerk, was present and kept the minutes of the meeting.

President Pro Tem Willis announced that the next item of business was to canvass the results of the August 23, 2016 municipal election.

City Clerk Richard Williams read aloud the results from the voting precincts. Following the Council's review of the vote results, Council Member McMinn introduced the following resolution and moved for its adoption:

WHEREAS, the general election for the City of Muscle Shoals was duly and legally held on August 23, 2016, as provided by law, and

WHEREAS, the municipal governing body of the City of Muscle Shoals met on this 30th day of August, 2016, with a quorum of the members thereof being present, at 12:00 o'clock noon and has canvassed the returns, and has ascertained and determined the number of legal votes received by each candidate, and

WHEREAS, the said municipal governing body has ascertained and determined the result of said election as follows:

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Muscle Shoals, Alabama, as follows:

That Chris Hall received a majority of the legal votes cast for the office of Council Member, Place No. 1 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2016.

That Ken Sockwell received a majority of the legal votes cast for the office of Council Member, Place No. 4 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2016.

That Allen Noles received a majority of the legal votes cast for the office of Council Member, Place No. 5 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2016.

BE IT FURTHER RESOLVED, that the Mayor of the City of Muscle Shoals be hereby directed to issue certificates of election to Chris Hall for the office of City Council - Place No. 1, Ken Sockwell for the office of City Council - Place No. 4, and Allen Noles for the office of City Council - Place No. 5 of the City of Muscle Shoals, Alabama for such terms pursuant to the provisions of Section 11-46-25, as amended.

Council Member Lockhart seconded the motion and upon said motion being put to a vote all voted "AYE" and "NAYS" were none.

President Pro Tem Willis announced that the motion had been approved.

There being no further business to come before the meeting, upon the motion duly made and seconded the meeting was adjourned.
