#### MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD August 5, 2019

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:20 p.m. on the 5<sup>th</sup> day of August, 2019 being the scheduled time and place for said meeting. The meeting was called to order by Allen Noles, President of the Council. The invocation was given by Ricky Williams. On roll call the following members were found to be present or absent, as indicated:

Allen Noles, President of the Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor David Bradford was also present. Ricky Williams, City Clerk, was present and kept the minutes of the meeting.

Upon motion duly made by Council Member Willis and seconded by Council Member Hall and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of July 15, 2019 and approved the minutes as written.

President Noles announced that the next item of business was consideration of a resolution to award a bid for a knuckle boom loader and truck.

**WHEREAS,** the City Council of the City of Muscle Shoals, Alabama approved the purchase of one (1) new, chassis with knuckleboom limb/brush loader to be utilized at Muscle Shoals Public Works; and

**WHEREAS**, the Procurement Agent did send out advertisements for bids for the purchase of a chassis with knuckleboom brush/limb loader, the bid opening being held August 02, 2019 at the City Hall of the City of Muscle Shoals, Alabama; and

**THEREFORE, BE IT RESOLVED** by the City Council of the City of Muscle Shoals that the apparent lowest, responsive and responsible bidder, Sansom Equipment Company is now awarded the bid for the purchase of a new, chassis with knuckleboom limb/brush loader unit for the total purchase price of \$127,189.00.

### ORDINANCE NO. \_\_\_\_\_ AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND ZONING MAP OF THE CITY OF MUSCLE SHOALS, ALABAMA

Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows:

That the following described area which are currently zoned R-2 and is hereby incorporated in and made a part of the B-1 District, to wit:

Lots 4675 Thru 4680 Highland Park Subdivision #12

At said time and place, all persons who desire to do so shall have an opportunity of being heard in opposition to or in favor of the adoption of such Ordinance.

President Noles announced that the next item of business was a request for the vacation of certain streets and alleyways in the Commercial Heights Subdivision as requested by the Muscle Shoals Electric Board.

Also all of that certain East West alley abutting Lots 13 through 47, inclusive in Block 4 and Lots 48 through 82, inclusive in Block 4.
