

**MINUTES FROM A CONTINUED MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD  
September 1, 2020**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 12:00 o'clock noon on the 1<sup>st</sup> day of September, 2020 in a meeting continued from August 17, 2020. The meeting was called to order by Mike Lockhart, Council Member.

On roll call the following members were found to be present or absent, as indicated:

Mike Lockhart, Council Member, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor David Bradford was also present. Ricky Williams, City Clerk, was present and kept the minutes of the meeting.

Council Member Lockhart stated the purpose of the continued meeting was to canvass the results of the August 25, 2020 municipal election and certify the results.

That Willis Thompson received a majority of the legal votes cast for the office of Council Member, Place No. 3 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.

That Ken Sockwell received a majority of the legal votes cast for the office of Council Member, Place No. 4 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.

**BE IT FURTHER RESOLVED**, that the Mayor of the City of Muscle Shoals be hereby directed to issue certificates of election to Mike Lockhart for the office of Mayor, Chris Hall for the office of City Council - Place No. 1, Willis Thompson for the office of City Council - Place

No. 3, and Ken Sockwell for the office of City Council - Place No. 4, of the City of Muscle Shoals, Alabama for such terms pursuant to the provisions of Section 11-46-25, as amended.

Council Member Lockhart called for a roll call vote to approve the resolution and the following vote was recorded:
