

**MINUTES FROM A CONTINUED MEETING OF THE
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD
October 13, 2020**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 12:00 o'clock noon on the 13th day of October, 2020 in a meeting continued from October 5, 2020. The meeting was called to order by Allen Noles, Council President.

On roll call the following members were found to be present or absent, as indicated:

Allen Noles, Council President, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor David Bradford was also present. Ricky Williams, City Clerk, was present and kept the minutes of the meeting.

Council President Noles stated the purpose of the continued meeting was to canvass the results of the October 5, 2020 municipal runoff election and certify the results.

City Attorney Marcel Black noted that there were no provisional ballots approved by the Board of Registrars. Council Member Sockwell introduced the following resolution to certify the runoff election results:

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Muscle Shoals, Alabama, as follows:

That Gina Clark received a majority of the legal votes cast for the office of Council Member, Place No. and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.

That David Moore received a majority of the legal votes cast for the office of Council Member, Place No. 5 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.

BE IT FURTHER RESOLVED, that the Mayor of the City of Muscle Shoals be hereby directed to issue certificates of election to Gina Clark for the office of City Council - Place No. 2 and David Moore for the office of City Council - Place No. 5 for such terms pursuant to the provisions of Section 11-46-25, as amended.

Council Member Lockhart seconded the motion and upon said motion being put to a vote, all voted "AYE" and "NAYS" were none.

Council President Noles declared the resolution approved by a unanimous vote.
