

MINUTES FROM A REGULAR MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA HELD  
August 19, 2019

The Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall in said City at 6:00 pm o'clock on the 19<sup>th</sup> day of August, 2019, being the regularly scheduled time and place for said meeting. The meeting was called to order by Allen Noles, Council President of the City. On roll call the following were found to be present or absent, as indicated:

Council Member Lockhart introduced the following Resolution in writing which was presented to the meeting:

**RESOLUTION NUMBER 3026 - 19**

**WHEREAS**, Act Number 2019 - 2, known as the Rebuild Alabama Act, was approved by the Alabama legislature to levy excise taxes on gasoline and diesel fuel, and

**WHEREAS**, Act Number 2019-2 provides for the distribution of a portion of these revenues to local governments for the construction, maintenance and repair of public roads, highways and bridges, and

**WHEREAS**, the legislation requires the development, approval and dissemination of an annual transportation plan by the governing body of the municipality, now

**THEREFORE BE IT RESOLVED** By the City Council of the City of Muscle Shoals, Alabama that the City of Muscle Shoals Transportation Plan for fiscal year 2020 be approved as presented, and

**BE IT FURTHER RESOLVED** that the City Clerk be directed to give proper notice of the approved Transportation Plan as required by Act Number 2019-2, and

**BE IT FURTHER RESOLVED** that the City Clerk is hereby authorized and directed to establish two separate bank accounts to be maintained by the City of Muscle Shoals for receipt and deposit of gasoline tax funds and diesel tax funds received pursuant to the Act at First Metro Bank.


