The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 4:00 p.m. on the 5th day of July 2023. The following members were found to be present or absent, as indicated:

Ken Sockwell, Council President, presided at the meeting. Mayor Mike Lockhart was also present. Brittney Walker, Finance Officer, and Kate McCollister, Administrative Assistant/Marketing, were present and kept the minutes of the meeting.

Mayor Lockhart discussed the planning proposal for the comprehensive plan. A detailed report was provided to the Council that included the following sections of information: Overview, Timeframe, Scope of Work (Planning Advisory Services and Special Projects), Compensation (Planning Advisory Services and Special Projects), and Reimbursement.

Mayor Lockhart also discussed the Allstar teams currently playing and their advancements. Two teams advanced, and the Mayor expressed how he wanted to support them by providing a \$1,500 sponsorship for each team.

The Council discussed setting a date for interviews for the Utilities Board. These interviews are scheduled for July 17 at 5:00 p.m. in the City Hall Auditorium.

Kathi Riley, Procurement Agent, discussed declaring the John Deere 6215 Tractor with Boom Cutter surplus and selling it to the Colbert County Commission in the amount of \$32,000.00.

Kathi Riley, Procurement Agent, presented two bids for the replacement of four retention pond motor feeders. Riley recommended the lowest bidder which was Shoals Electric Co. at \$66,000.00.




