

**MINUTES FROM A REGULAR MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD  
August 2, 2004**

---

The Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall in said City at 7:00 p.m. on the 2<sup>nd</sup> day of August 2004 being the regularly scheduled time and approved place for said meeting. The meeting was called to order by David Bradford, Mayor of the City. The invocation was given by Bill Howard. On roll call the following members were found to be present or absent, as indicated:

Richard Williams, City Clerk of the City, was present and kept the minutes of the meeting.

David Bradford, Mayor of the City, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business.

Upon motion duly made by Council Member Holland, seconded by Council Member Noles and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting of July 19, 2004 and approved the minutes as written.

Mayor Bradford announced that the next item of business was consideration of a resolution to award a bid for fuel products.

Council Member Noles thereupon introduced the following resolution and moved for its adoption which was presented in the meeting:

BE IT RESOLVED, by the Council of the City of Muscle Shoals, Alabama as follows:

[1] That the Purchasing Agent did send out advertisements for bids for the purchase of fuel products, the bid opening being held August 2, 2004 at the City Hall of the City of Muscle Shoals, Alabama.

[2] At the appointed time and place, as specified above, the following bids were opened and tabulated as follows:

[3] The lowest, responsive, responsible, bidder after evaluation and verifying the bid with the specifications for diesel fuel, has been determined as O'Steen Oil Company with a bid price of \$1.425. There being a tie of bid amounts between the two bidders, Council policy is to award to bidder who was not successful in the last bid award. Therefore, the bid for gasoline shall be awarded to O'Steen Oil Company as Tatum Oil Company was the last successful bidder for gasoline.

The apparent low and best bidder, O'Steen Oil Company, is now awarded the bid for gasoline and diesel fuels.

Council Member Willis seconded the motion and upon said motion being put to a vote, all voted "AYE". Voting "NAY" were none.

Mayor Bradford announced that the resolution had been approved.
